The Mall rally begins at noon.



#### Last summer, after almost 3 years of respectfully petitioning the government, Bob Schulz went on a 3-week hunger strike, risking death, to get the IRS and DOJ to answer basic questions about the legal authority for the federal income tax and the jurisdiction of the IRS.

In January, 2002, after formally agreeing to publicly provide official answers, both IRS and DOJ <u>reneged on their formal</u> <u>agreement</u>.

## We Must Defend The Constitution

The US Treasury has been auctioned to the highest bidding corporations, financiers and campaign contributors. Institutionalized greed for federal money and influence has cost us our rights, our civil liberties -- and <u>may soon cost us our</u> <u>Republic</u>.

US foreign policy, defense strategy and monetary interventions have birthed tragedy, fear and conflict worldwide. These were THE <u>direct causes of 9/11</u>.


Grand Juries are never told by judges that they have the power to <u>independently</u> <u>investigate</u> the government. Trial juries are never told of their right to judge the <u>facts and the law</u>. The courts have become tools of pillage that protect political power, improper private interests and the "status quo."

Under direct threats, including incarceration, we are forced to endure an income tax system that <u>violates virtually</u> every protection of our Constitution.

Former IRS agents, attorneys and others recently testified, under oath, that <u>IRS</u> personnel have **NO** bona fide, delegated authority in law to assess federal income taxes or seize property or wages. There is hard documentation that IRS personnel routinely and willfully commit crimes to extort taxes.

Although the 1st Amendment guarantees us the right to petition our government, the DOJ and IRS **refuse to**, and **cannot**, cite <u>any US law that</u> <u>specifically requires the average American</u> to pay income taxes or to file a return. Untold innocent Americans are in prison and have been financially ruined for failure to pay a tax, that under US law, <u>none of us owe</u>.

# Committed to Freedom and the Rule of Constitutional Law



Bob Schulz earned an engineering degree from the United States Merchant Marine Academy (1963), and a Masters Degree in Business Administration from Xavier University (1969). He completed most of the course work required for a Ph.D. in Public Administration at the Graduate School of Public Affairs, State University of NY.

Bob has held significant positions in industry (General Electric), in government (Connecticut, New York State, and the U.S. Environmental Protection Agency), on Wall Street (Prudential-Bache), as the founder and CEO of a consulting firm, and on the radio as a talk-show host (with WROW in Albany, New York).

Bob received an honorable discharge from the U.S. Air Force in 1959 and he answered his country's call by volunteering as a ship's engineer during the sea- lift to Vietnam in 1966.

However, this work and these assignments are not Bob's principal reason for being.

Although not an attorney, Schulz is not unskilled in law. Since 1979, Bob has been occupied with an abiding concern about wrongful governmental behavior and has been carefully evaluating governmental behavior and comparing that behavior with the requirements of the law and the state and federal constitutions.

For over two decades, when he has found wrongdoing he unhesitatingly confronted these improprieties in the courts -- professionally, intelligently and rationally. Bob performed the legal research, prepared the briefs and personally argued cases in the highest state and federal courts. At least one hundred fourteen (114) decisions have been rendered in cases he has brought against unconstitutional and illegal governmental behavior, prevailing on many important issues.

Since 1999 Schulz, as Chairman of the We The People Foundation for Constitutional Education (a 501(c)3 not-for-profit foundation) has waged and managed a nationwide educational effort aimed at forcing the U.S. government to answer to well researched and documented charges that the U.S. government has NO legal jurisdiction to enforce the income tax upon average Americans in the fifty states and that the IRS and DOJ unlawfully enforce the tax laws and routinely deny the constitutionally protected rights of American citizens.

As Chairman of the We The People Congress, Schulz is growing the Congress into an effective, grassroots, membership based, non-aligned activist organization capable of long-term citizen vigilance. Schulz's current objective with the Congress is to force the government to honor the people's petitions for redress concerning a wide spectrum of gross violations of civil rights being committed by our courts, elected leaders and the federal bureaucracy.

Bob and his wife, Judy, of 39 years live on a small farm off the East shores of Lake George, NY, where they raised four children -- each of whom graduated from one of America's finest universities.

- 1. What's your educational and professional background?
- 2. What brought you to this cause? What has WTP been doing for the past three years?
- 3. You say our nation faces a "Constitutional Crisis". How and why is this a crisis? Why are you focused on the income tax?
- 4. Why should the average person care about this? Don't we have a system that protects individual rights?
- 5. What is our government doing that is violating the Constitution?
- 6. Why is the 1<sup>st</sup> Amendment right to "petition for redress of grievances" so important?
- 7. Why is it so important to limit what government does to a strict interpretation of the Constitution? What does the future hold if the People do nothing?
- 8. You claim the "War on Terror" is destroying the Constitution and putting the nation at incredible risk. What are the ramifications of the these attacks on Individual Rights?

**5<sup>th</sup> Amendment**: How can the government force you to waive your 5<sup>th</sup> Amendment (Miranda) rights? Is filing voluntary or not?

**4**<sup>th</sup> **Amendment:** How can the IRS seize citizens' property, bank accounts, homes, etc. <u>administratively</u> without a court order or a signed judicial warrant?

Due Process: Is it true that U.S. Tax Court is a part of the IRS and not a "real" court?

16<sup>th</sup> Amendment: Was this a fraud? Isn't this just about some misspelled words?

The Federal Reserve: How are "money", income taxes and the "Fed" all related?

  - Former IRS agents testifying about deceptive IRS agent training
  - A forensic accountant w/ evidence that IRS agents tamper w/ IRS computer files.
