

1. On September 25th, the Income Tax System Will be Put On Trial.

On July 1st, Bob Schulz, a defender of the Constitution and Chairman of We The People Foundation for Constitutional Education, began a hunger fast to force the government to publicly answer specific legal questions that **directly challenge the legal jurisdiction of the IRS and the unlawful enforcement of U.S. income tax laws against citizens of the fifty states.**

On July 20th Dan Bryant, U.S. Assistant Attorney General and Rep. Roscoe Bartlett (Maryland) signed a written agreement committing tax and legal experts from the Department of Justice to answer these charges in a public and recorded hearing. IRS Commissioner Charles Rossotti also committed to send IRS representatives to the September hearing on Capitol Hill.

2. Specific Legal Charges :

- There is **NO law that requires** most Americans to file a return, pay income taxes or have any taxes withheld.
- The 16th (Income Tax) Amendment was **ratified by FRAUD.**
- If you file, **you have WAIVED** your 5th Amendment (Miranda) rights.

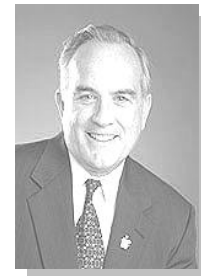
