Gentlemen:

An early response to this letter would be appreciated.

On May 5, 1999, and again on June 7, 1999, as you will undoubtedly recall, you received an invitation to have your most knowledgeable people participate in a symposium on the legality of the income and social security taxes, scheduled in Washington, DC at the National Press Club on July 1-2, 1999, to argue in opposition to the allegations of William Benson, Joseph Banister, William Conklin, Lowell Becraft, and Thurston Bell, whose research resulted in three propositions: 1) that Secretary of State Philander Knox fraudulently proclaimed in 1913 that the 16th Amendment had been ratified by the states, when, in fact, the states did not ratify the Amendment; 2) that there is no law that compels most Americans to file and pay income taxes or social security taxes; and 3) that Americans waive their 5th Amendment rights when they do file their income tax returns.

No one from the Executive or Legislative branches chose to acknowledge receipt of the invitations, much less appear at the symposium.

Please take notice that as a result of the July symposium, and in light of the preponderance of the evidence in support of the three propositions and the absence of any arguments by the political branches of the government in opposition, and in light of the fact that the Judiciary has concluded that the question of the fraudulent ratification of the 16th Amendment is a non-justiciable political question, it was decided that a Citizen's Summit would be scheduled this fall to launch a plan aimed at ending what is now being referred to as the greatest hoax ever perpetrated on any people by their government.


The Citizen's Summit, a "congress of the people," will take place on Saturday, November 13, 1999 at the National Press Club in the District of Columbia. Five copies of a Remonstrance will be signed by all citizens in attendance and delivered to the leaders of each branch of the government. This will signal the beginning of a national *Tax Honesty* movement aimed at ending the income tax hoax and the release of all political prisoners who are in jail unjustly for failure to file or pay illegal income or social security taxes.



Thank you for your consideration of this matter.


