The U.S. Income Tax System Goes On Trial February 27th!

HISTORIC HEARING ON INCOME TAX TO BE HELD IN WASHINGTON, DC

On July 20, 2001, U.S. Assistant Attorney General Dan Bryant and Congressman Roscoe Bartlett (MD) signed an historic agreement to hold a recorded, congressional-style meeting on Capitol Hill, in a public forum at which American citizens for the first time would have the opportunity to challenge the legality of the federal income tax. IRS Commissioner Charles Rossotti committed IRS representatives to participate.

This contract between the People and their government was designed to achieve an official and public answer to specific questions regarding the legal jurisdiction of the IRS and the improper and unlawful enforcement of the income tax laws against American citizens. Two full days of questioning were scheduled for February 27th and 28th at the Rayburn House Office Building on Capitol Hill. Rep. Bartlett would preside over the citizens' Truth-In-Taxation hearing.

However, both DOJ and IRS have now reneged on their commitment, deciding not to participate in any recorded, public forum. This has forced Bartlett to cancel the meeting on Capitol Hill. **The hearing will proceed as scheduled.**

The hearing will be held on February 27 and 28 at the Washington Marriott, located at 1221 22nd Street, NW, Washington, DC 20037, phone (202) 872-1500. We have now publicly demanded that DOJ and IRS be present. We expect them to fulfill their constitutional and legal obligations by attending the citizens' Truth-In-Taxation hearing and answering the People's proper Petition for Redress of Grievances relating to the fraudulent jurisdiction of the IRS and the illegal income tax system. We have now provided DOJ and IRS with an initial set of 299 questions.

Also, all learned persons in and out of the government, including members of the tax division on the American Institute of CPAs and the tax section of the American Bar Association have been invited to attend and to answer the questions.

WHY WAIT TO FILE?

Decades of research and a substantial body of legal evidence indicate the IRS does not have the legal authority to force employers to withhold income taxes from paychecks and that Most American Citizens Have No Legal Obligation To File Returns Or Pay The Personal Income Tax.

We extend an invitation to the event to every individual, who is concerned about the protection, preservation and enhancement of liberty in America, and who is interested in limiting the size, scope and costs of the federal government to the enumerated powers of the Constitution.

If the DOJ and the IRS do attend the event and provide honest, forthright answers to the people's questions relating to the authority of the IRS to force employers to withhold the income tax from the paychecks of their employees and to force most Americans to file a tax return, we believe the probable outcome will be a more limited federal government, a cleansing of our political system and a restoration of power to the states and the people.

We are calling on all patriotic Americans to help reveal the truth regarding the true limits to the federal taxing powers by standing up for our Country and its founding principles. In light of the decision by DOJ and IRS to ignore the People's fundamental, Constitutional right to petition our government for a redress of these grievances, we are respectfully requesting all Americans to:

- Demand that the IRS and DOJ attend the February hearing and publicly answer the questions, as they committed to do last July.
- 2) Wait to file their tax returns at least until February 27th. If IRS and DOJ fail to appear and answer the People's questions, we will then respectfully request every American citizen and business to defer filing of their tax returns and suspend employee withholding. The American People should not be obligated to pay a tax that the federal government will not publicly defend on lawful or moral grounds.
- Stand together on the mall in Washington, DC on Sunday, April 14, 2002, and peacefully protest the unlawful income tax by filing their blank 1040 forms in metal waste drums.

Do we still have a written Constitution in America? Do we still have a Bill of Rights? Do those documents still memorialize in writing what we believe most deeply in our hearts as Americans? Or have they become mere abstract concepts that have no real bearing on our moral conduct as nation? What good is our Constitution and Bill of Rights if we do not treasure them and protect them?
