### We The People Foundation Mission Statement

The We the People Foundation is a non-profit research and educational foundation. Our purpose is to promote a deeper understanding of the history and nature of America's unique constitutional system of government and the power it affords our citizens to hold government leaders at all levels accountable for their actions. The Foundation's programs facilitate effective civic action intended to compel government officials to obey our federal and state constitutions.

In short, the mission of the Foundation is to protect and defend individual Rights as guaranteed by the Constitutions of the United States and the fifty states of the Union.

We provide education and training to counteract the widespread public ignorance and apathy that hampers the development of effective citizen vigilance and the exercise of popular sovereignty, which are essential to the defense of our Constitution and our individual Rights and Freedoms.

The Foundation leverages its reputation and nationwide presence to engage in high-visibility, non-partisan public awareness and legal campaigns.

By combining highly professional research and public education programs with the penetrating analytical legal advocacy of a professional public-interest law firm, the Foundation is uniquely poised to stand as a clarion voice of Freedom and to undertake the direct challenges -- popular and legal -- necessary to check unconstitutional government.

Funded solely by tax-deductible donations, the Foundation coordinates its programs of legal advocacy, research and education with the grass roots civic activities of its sister organization, the We The People Congress.

This blend of civic education and civic action is designed to provide the People with the organization, power and money necessary to keep government at all levels within the boundaries drawn around its power by our written constitutions.

We The People Foundation seeks nothing less than the restoration of Constitutional Order to our land and the opportunity for our nation's children to experience the legacy of Freedom that so many have paid so dearly to secure.

### **General Objectives**

**Primary Objective:** To counteract public ignorance and apathy by educating the public about the history and nature of America's unique constitutional system of governance and the power it affords our citizens to hold all levels of government accountable.

**Secondary Objective:** To facilitate effective civic action to compel government officials to obey our federal and state constitutions by providing "constitutional activists" everywhere with information about their Individual Rights and how government is infringing on those Rights.

### **FY 2006 Objectives**

Secure from the federal judiciary a final declaration of our Rights under the Petition Clause of the First Amendment of the Constitution of the United States of America.

Establish the leadership and organization structure required to further develop and advance WTP's nationwide position, presence and influence. Establish national fund-raising programs to ensure success of the legal advocacy, civic action and educational objectives of the Foundation.

Engage in national debates and introduce multi-media campaigns to elevate public awareness of WTP's plans, programs and objectives. Promote measurable and widespread participation in the Foundation's constitutional education and civic action initiatives.

### Strategy

The Foundation will accomplish its mission by educating the public and facilitating effective civic action through a seven-part strategy.

### I. Legal Advocacy

In 2004, the Foundation initiated a landmark lawsuit to have the federal judiciary define the full meaning and contours of the last ten words of the First Amendment. For the *first time in our Nation's history*, the judiciary has been asked to formally confirm the meaning and power of the Right to Petition for Redress of Grievances.

In 2005 the United States District Court erroneously dismissed WTP's Right to Petition lawsuit, relying on specious reasoning and off-point case law. Astoundingly, the federal district judge in this historic case stated that the government, "does not have to listen or respond" to the People's grievances. By its decision, the court has attempted to effectively abolish, by judicial fiat, the People's Right to Petition our servant government for a redress of our grievances. If allowed to stand, this blatantly arrogant and unconstitutional lower court decision would establish a formal legal precedent by which government at all levels could ignore with impunity the constraints imposed on its conduct by our Constitution and Bill of Rights, and consequently destroy America's unique heritage of popular sovereignty—that is government of, by, for and accountable to the People.

In 2006, the Foundation will pursue the completion of the appeals process through the U.S. Court of Appeals and, if necessary, the United States Supreme Court.

An ancillary component of this strategy, initially defined in 2004, is a large dollar procurement of assorted media purchases (billboards, newspaper ads, radio, Internet, etc.) to build public awareness about the RTP lawsuit and garner the attention of the media as these profound questions about our Constitution are addressed by the courts.

Widespread public awareness and knowledge is crucial in insuring that the Judiciary is fully aware that the People are closely watching as it considers and rules upon this most important First Amendment "capstone" Right. The judges need to feel the searing white-hot light of public scrutiny.

The court must know the People will not surrender their unalienable Right to sovereignty over their servant government or subject this Fundamental Right to legislative manipulation.

The last thing the People need is another *Kelo* experience (eminent domain) where the government uses its judicial branch to cancel a Creator endowed Right and the Congress to replace it with a State granted privilege.

The Foundation's strategy of legal advocacy for 2006 also includes the prosecution and defense of a number of closely linked lawsuits, brought by (or against) RTP lawsuit plaintiffs. These cases, although primarily property and income tax related, are being worked in close conjunction with the primary RTP lawsuit. These cased are forcing confrontations and judicial decisions on subject matter congruent with the issues raised in the primary RTP lawsuit.

#### II. Restructure Board of Directors

Approximately two years ago, the Board of Directors for both the WTP Foundation and the WTP Congress began the process of restructuring with the intent to better serve the emerging national identities and missions of the organizations. Key to this process is the creation of an "advisory board" and the recruitment of Directors representing and articulating a national mission.

In 2006, the process will be completed with the appointment of several additional WTP Foundation Directors, both primary and advisory, comprising a unique mix of talent, achievement and commitment to the restoration of Constitutional Order.

### III. WTP HQ Relocation With Full-Time Professional Staff

Emerging events and circumstances fostered by a geometrically growing and complex national mission have resulted in a decision to permanently relocate the home offices of the WTP organizations in early 2006. The preferred new location is Washington, DC.

Although the organization has thrived to date in its original New York state location, relying significantly upon volunteer, discounted cost, and part-time contracted labor services, the pressing needs of our national mission and strategy clearly require a significant step-change in both our location and staff.

A DC-centric office will provide WTP with access to government officials and news outlets and be conducive to building significant working relationships with the many freedom organizations and like-minded advocacy groups based in the Capital area.

The massive work load associated with the Foundation's mission is now well beyond a level that can be accomplished by the current limited, but dedicated resources. If the organization is to succeed in its mission, it must have adequate funding to support and equip a reasonably sized, full-time staff of talented professionals, committed to the cause of Freedom and able to carry out the strategy of the Foundation and achieve its noble objectives.

The anticipated staffing plan includes positions for: project/program management, communications and research, information technology, finance and fundraising and administrative support.

Crucial to this high-cost initiative is communicating the importance of this step-change to the People and securing their financial support. It's time to put WTP on the map as the leader in the fight to restore the Constitution and its essential Principles.

### IV. GML2006

In 2004, WTP hosted a unique, ground-breaking conference in Washington DC called "Give Me Liberty 2004". This three-day gathering was broadcast live over the Internet and brought together leading voices of the Freedom movement to initiate a national dialogue about methods and plans to confront the growing attacks on the Constitution and the Bill of Rights.

In April, WTP will host another conference in DC - GML2006. The conference will focus on the Right to Petition and its application to affect solutions to the plethora of current constitutional abuses being committed by the government.

The 2006 conference will feature an assortment of Freedom leaders battling the abuses of the War Powers clauses, illegal immigration, property rights, privacy rights, gun rights, judicial corruption, vote fraud, monetary fraud, police state abuses, labor rights/economics, and the income tax fraud.

### V. <u>Hungering for Redress</u>

Immediately following the mid-April GML2006 conference in DC, there will be a mass hunger fast on the government's front steps to protest its refusal to respond to the People's Petitions for Redress of Grievances and Judge Sullivan's tyrannical Opinion and Order declaring the government does not have to listen or respond the People.

Although planned as a two-week fast (not to death) the public spectacle of a large number of Americans standing on the Constitution and "hungering for Redress" will be difficult for the media and government to long ignore.

It is entirely possible that the upcoming "Hunger for Redress" fast may draw the attention of many other rights organizations because of the potential the Petition clause holds in solving many of this nation's problems and holding our government accountable to the Constitution.

Reform movements, to be successful by peaceful means, must involve a mass-movement and be pro-active. This large-scale public fast will be a bold and necessary statement by the People that they will no longer tolerate a government that deprives them of their Natural Right of Sovereignty.

### VI. <u>Improved Communications & Technology</u>

The Foundation's strategy includes a number of technology related tactics aimed at improving its ability to effectively communicate with We the People.

**Liberty Hour** – Following the relocation of its main office, the Foundation will resume regular production and webcasting of the "Liberty Hour." The Liberty Hour video series will feature Rights-oriented guests and focus on the Right to Petition and its growing application as the solution to securing Freedom and restoring Constitutional Order.

**Revamped WTP Website** – The emerging role of the WTP Congress requires that the Congress evolve a separate and identifiable website presence. Until presently, the web functions of the Congress (e.g., Congress coordinator controlled web pages, Congress memberships, etc.) have been intertwined within the primarily Foundation oriented website. The new WTP website design strategy relies on a "portal" page to guide visitors to the Congress or Foundation websites and their respective functions. *See Attached draft.* 

WTP Blog -- "Blogging" is a new and powerful mode of harnessing the power of the Internet to communicate with large numbers of people. WTP intends to integrate a "blogging" strategy into its technology capabilities and to augment and compliment its main website, e-mail and (evolving) web video streaming functions. It is expected that "blogs" will be posted at least several times a week and may include multi-media such as audio files (e.g., recorded conference calls) graphics and links cross-referencing back to other WTP web resources.

**Virtual Video Conferencing** – Technology costs have fallen dramatically making live, video conferencing via the Internet feasible for use. The Foundation intends to employ this technology both for internal organizational use, and for interacting with other organizations.

**Educational DVDs** – WTP intends to produce DVDs for use in educating the public about the history, meaning, effect and significance of the provisions of our Founding Documents. They will cover the issues, challenges and risks our nation faces by abusive acts of government. The DVDs are intended to be shown at local WTP Congress meetings, local public events and on community access cable channels.

### VII. Organizational Development & Relationships

**Regional Campaigns** – In preparation for the April 2006 events (GML2006 and "Hungering for Redress"), the Foundation will host a series of regional meetings. The meetings are being scheduled to occur every weekend from mid-January through early April. The purpose of these meetings is to provoke awareness, participation and support regarding these important DC events.

**WTP Congress** – The We The People Congress moves into new territory in 2006 with its new operating plan. The Congress plan includes a strategy to self-finance its work and at the same time provide a significant source of funding for the work of the Foundation.

The primary elements of this program are the introduction of seven new Congress "regional coordinators" and the direct remuneration of all regional, state and county Coordinators. The Foundation will work closely with the Congress as it experiences its expected rapid growth and begins to exercise its activist "weight" in favor of the Foundation agenda. **Organization Relationships** – There are many organizations focusing on one abuse of power or another: unauthorized wars, illegal immigration, property rights, privacy rights, gun rights, judicial corruption, vote fraud, monetary fraud, police state abuses, and involuntary servitude.

While the Foundation must remain cautious about aligning itself philosophically with certain factions of thought, it behooves the Foundation to encourage these organizations to become familiar with and utilize the Right to Petition the government for Redress of Grievances as a means to resolve their own issues.



# We The People Foundation Organization



### **Organization Description**

Board of Directors: Establishes policy and oversees organization.

**Advisory Board**: Provides special skills and subject matter expertise; meets quarterly; provides advice and feedback to Board of Directors; non-voting.

**Chairman & CEO:** Chairs the Board of Directors, recommends and implements policy, manages staff and resources.

**Committees:** Executive, Finance, Fundraising, and Program committees, chaired by individual members of the Board.

**Manager, Finance and Fundraising**: Supports Treasurer, responsible for financial planning, management and fund raising. Works with outside accountants and auditors and is responsible for accounting records and practices.

**Manager, Communications:** Oversees internal/external communications, including "blogging," advertising, mailing lists, e-mail broadcasts, web content, and Liberty Hour programming. Coordinates with PR Manager.

**Manager, Administrative:** Manages day-to-day office operations, including phone, mail, travel reservations, office supplies, documents and files, order fulfillment, and product stocking.

**Manager, Information Technology**: Manages website maintenance, website design, server management, web streaming, technical project support, LAN, IT equipment/ software mgmt., technical contracts, and Liberty Hour production.

**Manager, Public Relations:** Responsible for building and maintaining relationships with other foundations, the media, universities and colleges and other non-governmental organizations.

**Manager, Projects and Programs**: Responsible for successful completion of Foundation projects and programs including events, conferences, educational product development, research initiatives, etc.

**Professional Services**: Contracted legal, accounting, independent auditing, technology support services, etc.
