Breaks Agreement: Will Not Answer Questions on Legality of IRS and Income Tax System

1st Amend. Petition for Redress of Grievances Ignored

On July 20, 2001 U.S. Assistant Attorney General Dan Bryant and IRS Commissioner Charles Rossotti formally agreed that DOJ and IRS would meet in a congressionally sponsored recorded public hearing on Capitol Hill to officially answer a detailed <u>legal inquiry</u> into the <u>legal validity</u> of the U.S. income tax system.

This agreement was the result of a citizen hunger strike and a formal **Petition for Redress of Grievances** submitted in April, 2000 to all three branches of the U.S. government. The petition, signed by thousands of American citizens seeks official answers to years of irrefutable legal research documenting many findings including:

- 1) There is <u>NO U.S. law or regulation</u> that explicitly imposes a legal obligation on the average citizen to pay any tax on their income, file a tax return or submit to tax withholding.
- 2) The 16th (Income Tax) Amendment was <u>fraudulently ratified</u> in 1913, and does not apply to normal wages and salaries.
- 3) You <u>voluntarily waive</u> your 5th Amendment (Miranda) rights when you file a tax return.



Project TOTO's objective is to expose the fraud of the U.S. income tax system.

On January 17, 2002 the government formally canceled the hearing. Memos and other evidence now indicate that IRS and DOJ officials never intended to appear and only agreed to it to halt the July 2001 citizen hunger strike on Capitol Hill and stifle the significant media attention and political pressure that was building.

Citizens Urged: "Wait to File Until the Trial!"

March on DC: April 14

Despite the government's refusal to appear in public and confront the legal research, the citizens' hearing will <u>proceed as scheduled</u> in Washington, DC on February 27 and 28. The **evidence will be unveiled** to the public and the tax system "tried" in absentia if IRS and DOJ refuse to answer <u>as they are required to under the law.</u> "Wait to File Until the Trial" on Feb. 27. **See the facts. Judge the truth. Pass the word.**

Citizens are urged to express their outrage at this <u>breach of the explicit protections provided by the U.S. Constitution</u> guaranteeing the right of the sovereign People to Petition our servant government and be answered.

If there is NO hearing with DOJ and IRS, the People will be called to a mass demonstration in DC on **April 14**.
