The U.S. Income Tax System Goes On Trial February 27<sup>th</sup>!

#### HISTORIC HEARING ON INCOME TAX TO BE HELD IN WASHINGTON, DC

On July 20, 2001, U.S. Assistant Attorney General Dan Bryant and Congressman Roscoe Bartlett (MD) signed an historic agreement to hold a recorded, congressional-style meeting on Capitol Hill, in a public forum, at which American citizens for the first time will have the opportunity to challenge the legality of the personal income tax.

At this unprecedented hearing, The United States Department of Justice and the Internal Revenue Service will officially and publicly answer specific questions regarding the legal jurisdiction of the IRS and the improper and unlawful enforcement of the income tax laws against U.S. citizens. IRS Commissioner Charles Rossotti has committed IRS representatives to participate.

#### WHY WAIT TO FILE?

Decades of research and a substantial body of legal evidence indicate the IRS does not have the legal authority to force employers to withhold income taxes from paychecks and that <u>Most American Citizens</u> <u>Have No Legal Obligation To File Returns Or Pay The</u> <u>Personal Income Tax</u>.

If these facts are confirmed publicly during this hearing, you may be able to claim a refund for ALL income taxes withheld during 2001.
