Historic DC Truth-in-Taxation **Hearing Held: IRS & DOJ** **Refuse to Contest Irrefutable** **Evidence & Sworn Testimony**

Ex-IRS Agents, **CPAs, Attorneys** **Testify Under Oath**

On July 20, 2001 U.S. Assistant Attorney General Dan Bryant and IRS Commissioner Charles Rossotti formally agreed that DOJ and IRS would meet in a congressionally sponsored recorded public hearing on Capitol Hill to officially answer a detailed legal inquiry into the legal validity of the U.S. income tax system. **On January 17th, the Government broke its agreement.**

On February 27 and 28, the People proceeded in a public hearing in DC with DOJ and IRS in absentia and revealed compelling and disturbing evidence and sworn testimony firmly documenting:

— There is NO U.S. law or regulation that explicitly imposes a legal obligation on the average citizen to pay any tax on their income, file a tax return or submit to tax withholding.

— The 16th (Income Tax) Amendment was fraudulently ratified in 1913 via gross violations of states' constitutions.

— IRS Agents have NO legal authority to seize your wages, home or bank accounts without a court order.

— IRS Agents illegally tamper with federal computer data files to illegally assess taxes on a routine basis.



Project TOTO is to expose the fraud of the U.S. income tax system.

— A 1957 U.S. Government report detailing the absence of legislative jurisdiction within the 50 states and therefore, the DOJ and IRS have NO legal authority to tax within any state.

— The income tax is a “slave tax” and is a form of peonage outlawed by the 13th Amendment barring slavery.
