## The landmark lawsuit

In 2004, almost 2000 dedicated Americans initiated a landmark federal lawsuit to have the Judiciary declare — *for the first time in history* — the constitutional meaning of the last ten words of the First Amendment, i.e., the Right to Petition the government for Redress of Grievances. The case is working its way through the federal courts and is destined to be heard by the United States Supreme Court.

## The Right to Petition is the direct exercise of Popular Sovereignty & Self-Government.

Originating in the Magna Carta in 1215, the Right to Petition is the most important Right enumerated in the Bill of Rights. If government has no obligation to answer Petitions for Redress, then government is the Master. If Individuals do not have a peaceful means to enforce their Right to Petition, then Freedom can be secured only through violence. The Right to Petition insures that We the People can directly and peacefully, challenge government's abuses of its delegated & limited authority.
